General Eligibility Requirements	<p>Fuel facilities shall:</p> <ul style="list-style-type: none"> <li>• Have gas, fuel and oil for cars, trucks and other vehicles</li> <li>• Have free public restrooms</li> <li>• Have a public telephone</li> <li>• Provide drinking water</li> <li>• Be in continuous operation for at least 16 hours each day and seven days each week throughout the year</li> <li>• Be located within one mile of the highway</li> </ul> <p>Food facilities shall:</p> <ul style="list-style-type: none"> <li>• Have a public telephone</li> <li>• Have free public restrooms</li> <li>• Provide drinking water</li> <li>• Be in continuous operation for at least 12 hours each day and six days each week throughout the year</li> <li>• Be located within three miles of the highway</li> </ul> <p>Lodging facilities shall:</p> <ul style="list-style-type: none"> <li>• Have at least 10 units, each with a private bath</li> <li>• Have off street parking for each unit</li> <li>• Have a public telephone</li> <li>• Be in continuous operation seven days each week throughout the year</li> <li>• Be located within three miles of the highway</li> </ul> <p>Camping facilities shall:</p> <ul style="list-style-type: none"> <li>• Have restrooms and showers</li> <li>• Provide drinking water</li> <li>• Have public telephones</li> <li>• Be located within seven miles of the highway</li> </ul> <p>Other attractions and businesses shall:</p> <ul style="list-style-type: none"> <li>• Have free public restrooms</li> <li>• Provide drinking water</li> <li>• Have public telephones</li> <li>• Be located within three miles of the highway</li> </ul> <ul style="list-style-type: none"> <li>• All businesses must be located on the crossroad.</li> <li>• All businesses must be licensed by all appropriate authorities and possess valid permits from all appropriate health departments.</li> </ul> <p><i>Note: If a business is denied participation, that business may appeal to NJDOT.</i></p>
